

# 2010 NRHA/Markel Insurance Futurity Sales Entry Checklist

Read the consignment contract carefully. If you have any questions, please call us.

**SALE CONSIGNMENT FORM. Fill out the form completely and neatly for each horse.**

The consignor's name, address and phone numbers. **This is how the consignor information will appear in the sale catalog.** (If consignor is an agent for the owner, the owner must complete an Authorization of Agent form.)

The current owner's name address and phones numbers (if different from consignor).

Select the sale (session) that best fits your horse.

**Breeders Showcase Sale (Select):**

\* For yearlings, broodmares, stallions and show horses. NO two year olds.

\* Video required for selection.

\* \$600 consignment fee

\* 8% commission on final bid

\* \$400 pass out fee

\* In the event your entry is not accepted, you may elect to submit the entry for consideration to the NRHA Marketplace Sale by checking the box on the entry form.

\* If your entry is not accepted and you choose not to place it in the Marketplace Sale, your consignment fee will be refunded.

**Futurity Prospect Sale (Select):**

\* For two year old reining prospects.

\* Video required for selection.

\* \$750 consignment fee

\* 8% commission on final bid

\* 8% pass out fee on final bid

\* In the event your entry is not accepted, you may elect to submit the entry for consideration to the NRHA Marketplace Sale by checking the box on the entry form.

\* If your entry is not accepted and you choose not to place it in the Marketplace Sale, your consignment fee will be refunded.

**Marketplace Sale:**

\* Mixed sale open to 175 consignments.

\* \$500 consignment fee

\* No video required for selection

\* 8% commission on final bid

Horse's name, breed, registration #, year foaled, color, sex, plus sire and dam info. Include all registries.

Complete information for Prospects:

\* **Eligible for:** Futurities or special programs where the horse is eligible and may still be entered and payments have not been made.

\* **Nominated to/Enrolled in:** Futurities or special programs where horse is paid up to date or fully paid up.

Complete the Broodmare information regarding service sire and breeding dates as well as 2007 & 2008 foal information.

Do a brief owner's statement, (your written sales pitch), as you would like it to appear in the catalog. Include show or produce record, or at least a summary, so we have this information for the selection process. Following selection, all consignment pedigrees will be professionally researched for cataloging.

**What to send with the entry?**

- Completed Consignment form
- Completed Disclosure form
- Consignment Fee by check or Credit Card.
- Original registration certificate(s)
- Signed transfer(s)
- Breeder's certificate for bred mares or letter from Stallion owner or manager.
- Video (2-3 minutes) for Breeders Showcase and Futurity Prospect Sales. Videos must be in VHS, VHSC or DVD format. Videos will not be returned unless requested.

**Selection Criteria**

We may not be able to accept all of the horses consigned to the Sales. The following selection criteria will be used:

- Quality of Horse (based on video appraisal)
- Show, Sire and Produce Record of the entry
- Pedigree & Record of Sire & Dam
- Date Received
- Consignor History with National Reining Horse Association.
