- All applicants must be at least 18 years of age.
- There is no earnings limit to apply.
- An Apprentice Program applicant may be subject to a personal interview with the Non Pro Committee.
- The applicant must apprentice with a member of the NRHA Professionals and physically work at that Professional's facility.
  All NRHA previous Non Pro as well as Open earnings will be used to determine the Apprentice's class eligibility. The
- Apprentice can only show in Open division classes during the apprenticeship period.
- Apprenticeship is a 12 consecutive month period. At the end of that time, the apprentice may remain an Open rider. In this case, previous Non Pro earnings will be backed out for eligibility purposes. If the Apprentice does not remain an Open rider, the Apprentice must then re-apply for Non Pro status and is subject to the Non Pro conditions. Any monies won during the 12 consecutive months Apprenticeship shall be applied to their Non Pro eligibility.
